MANAGER REPORT

PL-566 Updates

<u>Logan River</u> has been submitted to NRCS for review; the draft is anticipated to be ready this fall.

<u>Wellsville/Mendon</u> is finalizing some details, which are anticipated to be submitted to NRCS this spring.

State Funding for Water Studies

The mayors of the northern cities in the valley will meet on Thursday before an RFQ is sent out for the Northern Valley Study. Mr. Daugs, Mr. Pierce, and Ms. Neilson will meet with Rep. Snyder later this week to discuss altering some of the study funding funds and whether different projects would be allowed.

Other

Some cloud seeding has been done. The state is committing funds to transfer all sites to remote. The Clarkston weather site will be installed this summer.

2025 WATER LEGISLATION

Mr. Daugs provided a brief overview of the upcoming 2025 legislation as known so far:

<u>H.B. 41 State Water Policy Amendments</u> – Rep. Carl R. Albrecht - amends the state water policy to reference saved water and promote the quality of groundwater,

monitoring of activities in drinking water watersheds by watershed councils, state water planning and formation of the state water plan, and regionally appropriate water reuse.

H.B. 46 Water Rights Applications Amendments—Rep. Doug Owens will modify provisions related to the probate transfer of personal property by affidavit.

H.B. 45 Irrigation Amendments - Rep. Rex Shipp - if an owner or operator of a ditch or canal fails to exercise reasonable and ordinary care in maintaining the ditch or canal, the owner or operator is liable for damage to property or injury to others directly caused by the failure to exercise care in maintaining the ditech or canals, the owner or operator is liable for damage to property or injury to others directly caused by the failure to exercise reasonable and ordinary care. For a ditch or canal located within a municipality, if a person other than the owner or operator of a ditch or canal is held to be liable for damage to property or injury to others related to a ditch or canal, the person may recover the amount for which the person is held liable that is directly caused by the failure of the owner or operator to exercise reasonable and ordinary care concerning maintaining the ditch or canal.

H.B. 328 Water Usage Amendments - Rep. Doug Owens will regulate overhead spray irrigation in new or remodeled commercial, industrial, governmental, and governmental. An owner of a specified land who may undertake new development or redevelopment of specified land on or after January 1, 2026, may not install, maintain, or use overhead spray irrigation in a landscaped area of specified land unless the landscaped area is an outdoor activity area or undisturbed areas; shall install, maintain, or use overhead spray irrigation to irrigate the following withing an outdoor activity or undisturbed area: -Park Strip

- -Area with a width of less than 8'.
- -An area that is a planting bed or included within a planted bed or outdoor activity area is larger than reasonably required, and the anticipated area is intended to accommodate.

This does not prohibit an owner from using a reasonable amount of water to pray a landscaped area for non-irrigation purposes, such as dust control for a specific event in the landscaped area.

Modification to HB 453: The Division of Forestry, Fire, & State Lands (FFSL) is working on potential clean-up modifications to the statutory language in HB 453, specifically addressing berm management, voluntary agreement date, and other minor clean-ups. FFSL will collaborate with attorneys to compile recommended changes for presentation to the GSL Commissioners before the legislative session.

- Water Conservation and Irrigation: The Division of Water Resources is working with Rep. Owens on initiatives focusing on water conservation, particularly concerning the use of overhead spray irrigation or similar methods. WRe is examining conservation standards for drinking water and may propose these to Representative Owens.
- Limit the amount of water needed for each unit of growth: The Office of the Great Salt Lake Commissioner will work with the Division of Water Resources, the Division of

Drinking Water, the Division of Water Rights, districts, cities, and counties as well as the development community to establish a conservation standard for new development in the Great Salt Lake Basin. This could limit exactions for new water and lower the costs of new development. It will also enable existing water resources to be stretched for both growth and the Great Salt Lake.

- Changes to Procurement Law for Water Leasing: Modify procurement law to facilitate water leasing for the Great Salt Lake by the Office of the Great Salt Lake Commissioner.
- Tax credit for water donated to the Great Salt Lake: Similar to conservation easements, explore creating a tax credit for water donated to the lake.
