Update on PL-566 Applications

Should hear about the Crockett application this week. The Wellsville-Mendon project will be submitted the end of June/first of July (for the next cycle).

Localscapes Classes/Summer Interns

In-person classes were cancelled due to COVID restrictions. The Extension office held a zoom meeting with a few participants. A link to the recording will be provided.

Follow-up Board Member Training

Half of the Board have sent in their certificates. The remainder of the members were encouraged to complete the training and turn in their certificates.

July Meeting Date

A decision whether to hold an in-person meeting or an electronic meeting will be made in the next few weeks. Another suggestion was to hold the meeting in a larger venue to allow for social distancing. The cases of COVID have significantly increased in Cache County the past 5 days.

<u>Other</u>

Porcupine Highline Canal had a failure two weeks ago and are working to get some loan money to help pay for the repairs and make improvements. Mr. Clawson said the water travels up a steep hillside, it is a buried pipe in a cement-line ditch. As crews began digging, a spring was found on the uphill side, which caused a landslide. Mr. Daugs has been working with some canal companies on various issues.

Mr. Erickson noted that there are a few drainage districts in Lewiston who are re-organizing and it might be good for Mr. Daugs to reach out to them.

Mr. Daugs will begin scheduling sub-committee meetings.

Mr. Lindley said there will be a public meeting on the Wellsville-Mendon project tomorrow night at 7:00 at Wellsville City Office; members from the Bureau will be in attendance.

APO REPORTS

Sub-committees will begin meeting this month.

DISCUSSION – WATER RIGHTS/SHARES

Mr. Daugs said he has had a few individuals and groups calling. The District needs to come up with a plan of when/how to do begin. A sub-committee will be formed to begin the discussion.

Ms. Simmonds suggested getting copies of other District's policy templates. Mr. Daugs said he would get some and send them out to the members for review.

Mr. Clark recommended getting some direction from legal counsel. He also noted that how to protect shares should be discussed.

Mr. Clawson said it would make sense if the water could be leased back, otherwise there may need to be assessments paid.

Mr. Erickson pointed out that some companies have shares but no delivery system in place.

Mr. Daugs said there has been no announcement of who has been hired to work on the water banking program.
